# Human Rights Measurement Initiative (HRMI) Better data: Working together to advance human rights

Currently the world doesn't have a simple transparent way to monitor the extent to which people are treated with dignity in different countries. To fill this gap the Human Rights Measurement Initiative (HRMI) is working to produce a free easy-to-access database of thematic measures of Human Rights for countries.

This will allow NGOs, IGOs, National Human Rights Institutes, governments, and members of the public or citizen sector groups to see the big picture more easily and assist them in promoting change.

## Doesn't data like this already exist?

No. International bodies such as the UN encourage monitoring but do not produce quantitative measures of human rights compliance themselves. And existing measures are piecemeal and of varying quality.

HRMI will build on existing and previous efforts, and produce a suite of thematic human rights metrics that are simple, transparent, accurate, accessible and independent of governments.

We are currently working to identify approximately 12 countries for inclusion in the pilot. Selection is based on opt-in voluntary participation by human rights researchers. Country selection will be finalized by mid-2017.

#### This is a unique collaborative venture

Key contributors include:

Human Rights Researchers - To create our new Civil and Political Rights measures, researchers working for human rights NGOs around the world will complete a HRMI-administered online questionnaire at regular intervals. This will enable conversion of the qualitative on-theground information that researchers have into quantitative measures.

Measurement Experts - The HRMI team includes some of the world's most experienced experts in the field, including the prize-winning authors of the best existing measures of Economic, Social and Cultural Rights (the SERF measures) and the most widely used existing measures of Civil and Political Rights.

Future users of the data - HRMI's goal is to co-design human rights measures that meet the needs of future users of the data.



## Pilot phase metrics & quick methodology guide

In seeking to create a complete picture of human rights, we are not starting from scratch. Wherever possible we are building off existing efforts, and utilizing existing sources of internationally-comparable data, e.g. in the area of Economic Social and Cultural Rights (ESCRs). But there is a big data gap in the area of Civil and Political Rights (CPRs) where no satisfactory data exist. In this area we are developing a new methodology, based on an expert-opinion questionnaire approach, for a pilot group of countries.

- Right to freedom from execution
- Right to freedom from torture
- Right to freedom from arbitrary arrest
- Right to freedom from disappearance
- Right to opinion and expression
- Right to assembly and association
- Right to participate in government

- Right to Food
- Right to Education
- Right to Health
- Right to Housing
- Right to Work

# CPR Methodology

Our expert opinion survey methodology will provide an overview-level understanding of the frequency, distribution, perpetrators and victims in each of these thematic areas. By sourcing information directly from people whose job it is to monitor events on-the-ground in each country, these measures will be accurate, easily understood and independent of governments.

## ESCR Methodology

These metrics – the rights components of the SERF Index – have already been developed by the Economic and Social Rights Empowerment Initiative, and have received very positive reviews from the human rights community. Our goal during the pilot phase is to develop better data visualization tools, and to facilitate their growing use by NGOs and other users.

Our goal is to release our new CPR metrics in late 2017 or early 2018.

Beyond the pilot phase we will work with our partners to expand our country coverage. We would also like to expand our metrics to more directly illustrate the rights of specific groups (women, children, LGBT, refugees, etc).
